## WHAT YOU CAN EXPECT

Go ahead and search Google for "What does a CFO do?" Your not the only one – over 8,000 people do that same search each month. And no wonder it keeps getting searched for. There are a ton of different answers.

Most of the answers are geared towards large businesses. Many of the articles are written by authors that have never worked directly with a CFO. They are merely quoting theory around what a CFO should do. The fact is, the job has evolved over the past few years.

With our finance background and being an entrepreneur, we strived to build a package that brings actual value to business owners.

We join or help you create a monthly leadership team. We meet with you and this team every month. This meeting typically has three agenda items:

- Review: We review your financial results with our in-depth financial reporting package. Our goal is to make sure you track the factors that drive value and have clarity into the business. We don't spend time reviewing things that don't matter. We want to give a high-level picture of how the business is performing.
- Plan:We have a 12-month rolling forecast for all of our clients. A large portion of this meeting is spent reviewing the forecast to determine if the business is on track to accomplish its goals. We look at cash flow each month to help the business manage their obligations and identify potential issues.

## WHAT YOU CAN EXPECT

• Strategy: We are big believers in Traction by Gino Wickman. However, we also know that a full traction implementation might not be realistic (or needed) by most small and medium business owners. Therefore, we have taken the best parts of the system and condensed it into a monthly process. We set quarterly goals and track them to make sure that the business is aligned and moving forward.

These are the three areas where we believe virtual CFO services can add the most value for business owners. Along with this, we are here to answer day-to-day questions. Have a question about how to collect AR faster? We're here to help.

One of the best parts of our virtual CFO services is flexibility. We can work with your current bookkeeper in place. If you value that relationship, we don't want you to change it. However, if you value consolidating your finance and accounting department, we have bookkeeping available as well.

All of our services revolve around the monthly meeting. This is a 2-hour meeting, often in the middle of the month, with your leadership team. We know you are busy, so we condense all of the work we do in the background into this monthly meeting.

## THE ONBOARDING PROCESS

Our onboarding process will take approximately four weeks to get fully settled in. Our purpose during this period is to properly gain a solid understanding of the company's financial and operational procedures in order to assess its current financial health and opportunities for improvement.

During onboarding we will assist with things such as customizing your chart of accounts so that it is consistent with our planning and your peers, reviewing prior year tax returns, reviewing company policies, developing your KPIs, setting up your custom forecast, etc. We run a thorough risk assessment, looking at your buy/sell agreements, your insurance policies, employee incentive plans, etc.

We do have a standard on-boarding fee of \$1,650.
